Notification

Dear Ms. Hardy:

On behalf of Nisus Corporation, I am submitting a notification for the product QNAP 1W Copper Naphthenate RTU (EPA Reg. No. 64405-20). The purpose of this notification is to make the following changes:

- 1. Add the term "First Aid" to the reference statement located on page 1.
- 2. Add the coverage range for application level of 0.88 gallons of product. The 0.88 gallon use-level is being added since a Nisus distributor wishes to market the product in a container that contains slightly less than 1 gallon of product. The 0.88 gallon use-level is consistent with the current approved label rate for a use-level of 1 gallon and the treatment area covered. Accordingly, we believe this notification is consistent with "Section M, Item 1" (page 7) of PR Notice 98-10 since this provision allows changes in the use instructions to accommodate different package sizes.
- 3. Make minor typographical edits.

It may also be used to protect [kill] [control] [prevent] [stop] [resist] warping, swelling, shrinking, end checking [due to its anti-wicking property, which resists moisture absorption and movement from end to end] [caused by changes in moisture content of wood products], rot [wood rot], mold and mildew, and moss.

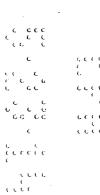
