


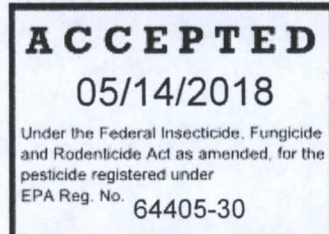

Place pea-sized applications of bait not less than 4" [four] [inches] apart. Apply enough bait so there is adequate bait supply between applications.

**OUTDOOR:** Place bait close to cockroach harborage, foraging and feeding areas such as cracks and crevices, horizontal and vertical surfaces. Place pea-sized applications of bait not less than 4" [four] [inches] apart in areas protected from rain and direct sunlight.

**Application specifically for food processing and handling establishments, including federally inspected poultry and meat plants: In food areas, only apply product into cracks, crevices and other inaccessible areas.** Do not contaminate food and feed stuffs.
