The Agency, in accordance with the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, has completed reviewing all of the information submitted with your application to support the Registration Review of the above referenced product in connection with the Boric Acid Interim Decision, and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

OUTDOOR: Place bait close to cockroach harborage, foraging and feeding areas such as cracks and crevices, horizontal and vertical surfaces. Place pea-sized applications of bait not less than 4" [four] [inches] apart in areas protected from rain and direct sunlight.

Application specifically for food processing and handling establishments, including federally inspected poultry and meat plants: In food areas, only apply product into cracks, crevices and other inaccessible areas. Do not contaminate food and feed stuffs. Do not apply product directly onto a surface where food is prepared, served or stored.
