**PRECAUTIONARY STATEMENTS
HAZARDS TO HUMANS & DOMESTIC ANIMALS**

Corrosive to eyes, skin and mucous membranes in the presence of moisture. May be fatal if inhaled. Do not breath air containing this gas. Do not get on skin, eyes or clothing. Wear chemical resistant gloves, chemical resistant apron and goggles or face shield when using this product. Remove contaminated clothing and wash clothing before reuse. ENVIRONMENTAL HAZARDS

This pesticide is toxic to fish. Do not discharge into lakes, streams, ponds or public water, unless in accordance with an NPDES permit. For guidance contact the regional office of the Environmental Protection Agency.

CHEMICAL OR PHYSICAL HAZARDS

Chlorine is a non-flammable gas, liquefied, under pressure. Do not drop container. Keep away from intense heat or open sunlight. Corrosive to most metals in the presence of moisture.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Have available, gas masks approved by the U.S. Bureau of Mines or the National Institute for Occupational Safety and Health. Handle and use only in accordance with practice recommended in the "Chlorine Manual" published by the Chlorine Institute, Inc., New York. Use only in well ventilated areas.

Only specifically designed dispensing equipment should be used in accordance with manufacturer's instructions and according to state regulatory agency recommendations for dosages or residual chlorine levels which should be maintained for each specific site of application.

STORAGE & DISPOSAL

Storage: Keep containers away from heat. Do not store in direct sunlight. Do not drop containers. **Disposal:** Empty containers should be properly identified with return tags and returned to the supplier according to prescribed instructions and practices by the supplier.
