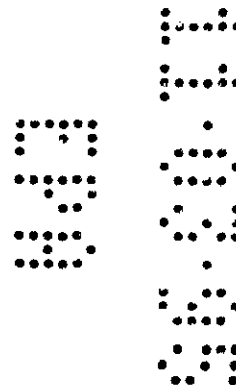

This product may be hazardous to aquatic invertebrates. Do not hang pouches or place them in an area where runoff may contaminate any body of water.

Directions for Use

It is in violation of Federal Law to use this product in a manner inconsistent with its labeling.

Use Restrictions

This product may be used to protect established and new plantings of shrubs, small trees, and flowers from damage caused by white-tailed deer (*Odocoileus virginianus*). Under conditions of low to moderate deer pressure, this product may remain effective for several months. When deer pressure is intense, the effectiveness of this product may diminish markedly after a few days.

APPLICATION DIRECTIONS

New Plantings and New Growth: Hang pouches of Repel-Bye Deer from stakes at height of bud level. Elevate pouches as plants grow to keep repellent at bud level.

Clusters of the Same Flora: Stake pouches of Repel-Bye Deer randomly throughout plantings and always at bud level.

Shrubs and Small Trees: Hang pouches of Repel-Bye Deer from stakes or tie to shrubs or small trees at various browsing levels around the circumference of the shrub. Shrubs will require approximately 2-4 pouches each. Note that deer may browse up to heights of 5 feet or more and tend to browse relatively small plants from the top down.

STORAGE AND DISPOSAL

Storage: Keep container closed and away from exposure to sunlight and water.
Disposal: Do not reuse container or pouch. Discard in trash.
