
1. Delete the statement "If odor is noticeable on skin when protection is no longer needed, wash product off skin", and add the following statement to the product label, as indicated in the DEET LIP:

Do not use under clothing. After returning indoors wash treated skin with soap and water. Wash treated clothing.

2. Although we would prefer inclusion, we have determined that it is acceptable to remove the statement "If you go to a doctor, take this repellent with you" from the product label. You may remove this statement from the label without submitting an amendment.
