The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable provided that you:

1. Make the label changes listed below before you release the product for shipment bearing the amended labeling:
 - a. Since the word "CAUTION" is used for the signal word in the precautionary language for this product, it must be deleted from the section regarding Directions. Although the word "CAUTION" in this section agrees with the signal word in this case, it is still inconsistent with Agency policy that this heading be reserved for the signal word only. It may be replaced with a word such as "PRECAUTION" or "ATTENTION" that may draw the user's attention but would not be confused with a toxicity category.
 - b. In the chart regarding the seasonal application of this product, there is a typographical error. Please change "Conrol" to "Control".
2. Submit one (1) copy of your final printed labeling before you release the product for shipment.

DIRECTIONS

3. Water thoroughly immediately following application.
4. Dead moss may be raked out.

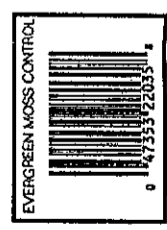
