Dear Mr. Kieniksman:

The labeling referred to above submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments specified in my letter and listed below: A stamped copy of the label "accepted with comments" is enclosed for your records.

The recommended wording for First Aid for If swallowed are presented in the following table:

FIRST AID

Have the product container or label with you when calling a poison control center or doctor or going for treatment

^{*}Application in 50 - 100 gallons of spray per acre is preferred but not required depending on spray equipment.

DO NOT use when the soil (especially the sub-soil) is relatively dry.

DO NOT use when freezing temperatures are expected.

DO NOT use when the temperature is above 95 degrees Fahrenheit.

DO NOT use with Captan, Omite, Sulfur, Lime Sulfur or Methoxychlor.

DO NOT use oil 60 days before or until 90 days after Sulfur or Captan products.

TANK MIXES: Leffingwell Supreme 415 Oil may be tank mixed with other pesticides. When tank mixing with other pesticides, check compatibility before mixing in application equipment. Follow all precautions and instructions on pesticide labels being tank mixed.

Leffingwell Supreme 415 Oil is compatible with Nutra-Spray® foliar nutrient powders which may be used at the rate of 1 1/2 to 3 lbs. per gallon of spray mixture.

LEMONS, ORANGES, GRAPEFRUIT, OTHER CITRUS VARIETIES - Red Scale, Yellow Scale, Purple Scale, Black Scale, Brown Soft Scale, Citrocola Scale, Citrus Red Mite, Citrus Bud Mite, Pacific Mite, Two-Spotted Mite: 1.2 to 1.4 gals. per 100 gals. of water with thorough coverage in Southern California, April through May and/or September through December. In Central California, July through September. Higher dosage is recommended for heavier infestations in early fall. To aid the control of Red, Black, Yellow or Purple Scale add a suitably labeled insecticide. See below for Low Volume and additional Black Scale uses.

ORANGES AND LEMONS (LOW VOLUME APPLICATION) - Citrus Red Mite: Apply at the rate of 15 to 20 gals./acre by helicopter, low volume modified speed sprayer, or other low volume sprayer. Observe all cautions for proper practice noted on this label.

Leffingwell Supreme 415 Oil may also be used as a spreader-sticker with insecticides or miticides at a rate not to exceed 1.0%.

ALL CITRUS VARIETIES; Black Scale - Apply at the rates recommended above as soon as practicable following completion of major hatch. When treatment has been delayed and larger stages are present, add a rotenone-containing product or other suitably labeled insecticide according to its label directions. When an additive is used, the oil dosage may be reduced to 3 qt./100 gal. water. As an emergency treatment, the 3 qt. combination rate may be used later in fall months than an oil spray at full dosage.

YOUNG NON-BEARING CITRUS; Mites - 1.2 gal. per 100 gallons of water during spring, late summer, and fall months with thorough coverage.

APRICOTS, ALMONDS, CHERRIES, PEACHES, PLUMS, PRUNES and OTHER STONE FRUIT - Summer use: Red Mites - 1 gallon Leffingwell Supreme 415 Oil in 100 gallons of water or 6 gallons per acre in 100 to 300 gallons of water with the following special recommendations in addition to the general cautions: 1)DO NOT apply over certain fresh market fruits after bloom starts to form as the oil spray will remove waxy bloom. 2)Application should not be made over oil sensitive varieties of plums, apricots and almonds. NOTE: On prune trees sensitive to oil, application should be made in the period between February 15 and the popcorn stage. Summer stage (post harvest): Brown Apricot Scale, San Jose Scale - 1 to 1.5 gals. per 100 gallons of water. Dormant or Delayed Dormant: San Jose Scale, Parlatoria Scale, Brown Apricot Scale, Black Scale, Mite Eggs, Aphid Eggs - 2 gals. per 100 gallons of spray mixture. Delayed Dormant: Leaf Roller Eggs - 2.5 gals. per 100 gallons of spray. APPLES AND PEARS - Summer application: Red Mites - 1 gal. per 100 gal. of water. DO NOT apply over iruit after waxy bloom forms as oil will remove the wax. Immature summer stage (post harvest): San Jose and Italian Pear Scale - use 1 to 1.5 gals per 100 gallons of spray. Dormant and Delayed Dormant: San Jose Scale, Italian Pear Scale - 1.5 to 2 gals. per 100 gallons of spray mixture. Delayed Dormant: Leaf Roller Eggs - 2.5 gals per 100 gal. of spray mixture. Pear Psylla - 1 gal. per 100 gal. of spray mixture.

AVOCADOS - HAAS VARIETY ONLY - Avocado Brown Mite, 1 gal. per 100 gallons of writer with thorough coverage through late fall.

GRAPES DORMANT - Mealy Bug - 1 gal. per 100 gallons of water.

OLIVES - Pariatoria Scale, Oleander Scale: Post bloom to June 30, use 1 1/2 gal. Leffingwell Supreme 415 Oil per 100 gallons of water, or 1 gal. this product plus a carbaryl-containing insecticide according to its label directions. July 15 to 60 days before harvest, use 1 1/2 gal. of product per 100 gallons of water.

Black Scale: After initial hatch in August 10 to 20, use 1 to 1 1/2 gal. Leffingwell Supreme 415 Oil per 100 gallons of water.

WALNUTS - NOTE: Oil may cause damage on walnut trees that have been dry or poorly fertilized.

San Jose Scale: Emergency treatment only. Consult local agricultural extension service before using. Use 0.8 gal. Leffingwell Supreme 415 Oil per 100 gal. of water with a diazinon-containing insecticide according to its label directions. Apply post-bloom through June 1. DO NOT exceed 4 gal. this product per acre.

STORAGE AND DISPOSAL

DO NOT contaminate water, food or feed by storage or disposal.

STORAGE: Store in a dry location.

PESTICIDE DISPOSAL: Pesticide wastes are acutely hazardous. Improper disposal of excess pesticide, spray mixture or rinsate is a violation of Federal Law.
