It is most effective when applied before animals develop their feeding habits and damage has occurred. Because Hinder RTU works on an odor principle, it repels deer and rabbits before they eat treated plants and helps to protect new growth as it begins to emerge. The objective in using Hinder RTU is to divert animals to alternative food sources and away from valuable plants. When animal feeding pressure is extraordinary (as in drought conditions) no product can be 100% effective; animals will feed even on treated plants rather than starve.

#### **USE RESTRICTIONS**

This product may be used to limit browsing by white tail deer (<u>odocoileus</u> <u>virginianus</u>) and black tail or mule deer (<u>o. hemionus</u>), on ornamental trees and shrubs, annual and perennial flowers, nursery stock, soybeans, peanuts, apple and pear trees, and carrots.
