Apply as a spray, flood or dip with contact period of 30 to 60 seconds. Flush fruit with fresh water after treatment. *Tolerance* - 10 ppm from postharvest application expressed as o-phenylphenol.

Pears: Postharvest control of bacterial and fungal decay rots. This product is concentrated and should be diluted one (1) gallon SOPP Soap with nine (9) gallons of water to make a 2% sodium ortho-phenylphenate tetrahydrate treating solution. Apply as a spray, flood or dip with contact period of 15 to 30 seconds. Flush fruit with fresh water after treatment.

Tolerance - 25 ppm from postharvest application expressed as o-phenylphenol.

*Not for use in California for control of Citrus Canker or on Pears.

STORAGE & DISPOSAL

Do not contaminate water, food, or feed by storage and disposal.

Pesticide Storage: Store this product in a cool, dry area away from direct sunlight and heat to avoid deterioration. In case of spill, flood areas with large quantities of water.

Pesticide Disposal: Product or rinsates that cannot be used should be diluted with water before disposal in a sanitary sewer.

Container Disposal: Nonrefiliable container. Do not reuse or refill this container. Clean container promptly after emptying. Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank. Fill the container ¼ full with water. Replace and tighten closures.
