Hazards to Humans and Domestic Animals

Discard clothing or other absorbent materials that have been fogged or heavily contaminated with the product's concentrate. Do not reuse them. Follow manufacturer's instructions for cleaning/handling PPE. If no such instructions for washables, use detergent and hot water. Keep and wash PPE separately from other laundry.

User Safety Recommendations

- Users should wash hands before eating, drinking, chewing gum, using tobacco or using the toilet.
- Users should remove clothing immediately if pesticide gets inside. Then wash thoroughly and put on clean clothing.
- Users should remove PPE immediately after handling this product. Wash the outside of gloves before removing. As soon as possible, wash thoroughly and change into clean clothing.

Application Restrictions

DO NOT apply this product in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application. Consult Agricultural Experiment Station or Extension Service pomology specialists for current DPA use-solution concentrations for local apple varieties.

- DO NOT rinse apples after treatment.
- DO NOT apply diphenylamine to apples before harvest.
- DO NOT use treated apples for pomace or livestock feed as illegal residues may occur in meat or milk.
- DO NOT make more than 2 applications to apples.
- DO NOT apply diphenylamine to apples via treated wrapping papers.
- Fruit must have shipping carton marked: "Treated with Diphenylamine to retard spoilage."

In case of prolonged storage (more than 4 months) or particularly high danger of scald due to climatological conditions, a second treatment may be advisable between the second and third months of storage. This second treatment must be applied at a rate of between 50% and 100% of the initial dosage, depending on the importance of the danger and the length of further storage. If needed, use a second treatment of 100% of the first dose for any additional storage of 3 months or longer.

Preparation for Fogging

- Fog dry fruit for best results.
- For best results, treat fruit as soon as possible after harvest preferably within 15 days after harvest.
- Before treatment, top bins can be covered with plastic liners, cardboard, or Kraft paper sheets to prevent excess chemical residues. Protect fruit directly in front of the fogging equipment with liners or sheets from top to bottom.
- When treating rooms that are less than 75% full, calculate the dosage of eFOG®-300 DPA by adding a tonnage value of 20% of the empty volume to the real tonnage of the fruit.

Electrofogger Operation

- Place the Electrofog machine horizontally outside the treatment room at a height of about 3 feet from the floor.
- Cover the door or window to the treatment room with a plastic sheet or portable fogging door and insert the fogging pipe through the hole in the plastic or the door.

- Place a bucket under the nozzle to catch any drops. Seal the opening around the nozzle.
- Insert the pump suction tube into the product container and start the pump.
- Set the Electrofog controls to reach and maintain a fog exit temperature of 200°C.

Application Procedures

- Avoid breathing the fog.
- Turn off room cooling systems and humidifiers 2 hours prior to and during treatment.
- Turn off room circulation fans immediately prior to and during treatment.
- Allow the fog to stay overnight or until the fog has totally disappeared (about 5 hours post-treatment) before restarting fans and cooling systems.

Posting

Notify workers of the application by warning them orally and by posting warning signs at entrances to treated areas.

Re-Entry

Entry into the treatment area by any person other than properly trained and equipped handlers is prohibited from the start of application until the treated area is ventilated as follows:

- 8 hours with no ventilation followed by 1 hour of mechanical ventilation
- 24 hours with no ventilation

In case it is necessary to enter the treatment area during treatment or before ventilation requirements have been met, handlers must wear chemical resistant headgear and a self-contained breathing apparatus (SCBA) with NIOSH approval number prefix TC-13F in addition to PPE listed under PRECAUTIONARY STATEMENTS.

Check for Post-Treatment Signs of Scald and CO₂ Injury.

In years of severe scald development, eFOG®-300 DPA may not give desired control or other factors may reduce its effectiveness. After several months of storage, collect samples of fruit periodically (every 2 or 3 weeks) and hold them at room temperature to assess scald development and CO₂ injury. Fruit lots showing scald can often be marketed immediately.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

<u>PESTICIDE STORAGE</u>: Avoid storing below 40° F. In case of spill or leak, absorb liquid with sawdust or other absorbent material and incinerate or dispose of it in approved disposal area. <u>PESTICIDE DISPOSAL</u>: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

<u>CONTAINER HANDLING</u>: [Containers equal to or less than 5 gallons]: Nonrefillable container. Do not reuse or refill this container. Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank and drain for 10 seconds after the flow begins to drip. Fill the container ¼ full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times. Then offer for recycling, if available or puncture and dispose of in a sanitary landfill.

[Containers greater than 5 gallons]: Nonrefillable container. Do not reuse or refill this container. Triple rinse container (or equivalent) promptly after emptying. Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank. Fill the container ½ full with water. Replace and tighten closures. Tip the container on its side and roll it back and forth, ensuring at least one complete revolution for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. Then offer for recycling, if available or puncture and dispose of in a sanitary landfill.
