This is in regard to your label re-submitted in response to the Agency letter dated September 28, 1992. That Agency letter was in regard to your label amendment prompted by a USDA letter stating that your product may not be used as a food-contact surface sanitizer at concentrations over 100 ppm available chlorine.

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. A stamped copy is enclosed for your records.

1. Delete the last sentence in the "General Sanitization" section -- "Rinse any treated food contact surfaces with potable water before reuse."
2. Submit five copies of the finished labeling before you release the product for shipment bearing the amended labeling.

The primary brand name for this product in our records is now "CL-600," as per your request.

DIRECTIONS

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

EGG SANITIZING: For use as a final sanitizing spray after washing eggs, prepare a spray solution by adding 1 ounce CL-600™ per 14 gallons of water. Maintain temperature of 110-130°F.

GENERAL SANITIZATION: Use on walls, floors, tables, sinks and any furnishings not damaged by water. Prepare a solution containing 1 ounce of CL-600™ per 7 gallons of water. Apply in a wetting concentration. ~~Rinse any treated food contact surfaces with potable water before reuse.~~

FOOD PROCESSING AND BEVERAGE EQUIPMENT: For sanitizing equipment that has been previously cleaned, use a solution containing 1 ounce of CL-600™ per 14 gallons of water. Apply in a wetting concentration. Drain and allow to air dry before use. Where local or state ordinances are in effect, follow the required procedures.

STORAGE & DISPOSAL

STORAGE: Keep product dry in tightly closed container when not in use. Store in a cool, dry, well ventilated area away from heat or open flame. In case of decomposition isolate container, if possible, and flood with large amounts of water to dissolve all material before discarding.
