

DISPENSER INSTRUCTIONS: Following the instructions below, remove cap, extend chalk and lock in position for application. After use, retract chalk and close cap making sure it has locked in position.



I. TO REMOVE CAP: PUSH DOWN AND TURN.

2. TO EXTEND CHALK:
PRESS BUITON DOWN, ALLOW CHALK
TO SLUDE 4 INCH OUT OF OTENING.

NELEASE BUTTON TO LOCK

3. TO RETRACT CHALK:

Hold tube lipright (over end ut).
Press button in all tie way.
Allow clialk to pall completely inside
Holder, before releasing button.

4. CLOSE CAP PROPERLY.

APPLICATION INSTRUCTIONS:

ZE LIN CHEN CHALK, properly applied, forms barriers over which insects must crawl to enter the facility or to get to and from food and water. These carriers are formed by drawing treatment bands. These treatment bands must intersect without breaks or gaps for complete, and effective barriers. A single band or bands, the width of the chalk, is effective. Wider bands are unnecessary.

Draw a ZE LIN CHEN CHALK band completely around the underside of all shelving. Remove all drawers and draw treatment bands completely around the underside of the countered and all interior sides of the cabinet. Do not apply to the interior of drawers or to the front exterior of the cabinets. In the home do not allow the insecticide to contact food or food processing surfaces. Give special attention to treating under and around the sink. Band cabinet exteriors where they join the wall or at points of cracks or crevices. Do not allow the insecticide to contact food or food processing surfaces.

Draw a band of ZE LIN CHEN CHALK around the cabinet base and baseboards of the entire home or facility, the flat surface around each door casing, under the shelving in closets and storage areas, and on the back of pictures. Treat throom vanities in the same manner as cabinets. This application will ensure at insects crawling along and up walls will come in contact with the insecticide barrier. Interior and exterior casings and exterior thresholds may be treated for control of CRICKETS, ANTS and ROACHES.

NOTE: Product effectiveness is likely to be reduced in areas wet enough to dampen treatment bands.

Other areas to be treated include baseboards, moldings, around plumbing and other utility installations, dark corners in closets, and around doors, ventilators, windows and other openings. Completely band the undersides of work tables and storage shelving. Floor drains, garbage rooms, locker rooms, switch boxes, and the back of switch plates should be included in the treatment.
