IMPORTANT CONSUMER INFORMATION:

PURPOSE: FLEAGO is a flea killing powder. It is a dry crystal powder that works on the carpet and under the cushions of upholstered furniture to kill fleas.

DIRECTIONS FOR USE: It is a violation of federal law to use this product in a manner inconsistent with its labeling. Unscrew cap and remove sealer. Replace cap securely.

USE RESTRICTIONS: Children and pets should not be in treatment area until after application is completed. Do not treat pets with this product. Avoid contamination of feed and foodstuff. Avoid contamination of ornamental plants.

CARPETS:

- Apply to dry carpet only.
- Vacuum all carpeted areas in your home.
- By shaking container from side to side lightly sprinkle FLEAGO evenly over entire carpeted areas including under beds and furniture where carpet can be seen. Any powder visible after application must be brushed into carpet fibers or removed.
- Please wait at least 5 days before vacuuming treated areas.

UPHOLSTERY:

- Remove loose cushions. Apply along creases and into corners and furniture wells. Do not apply product on top of cushions.
- Any product visible after application must be removed.

REMEMBER, FLEAGO requires approximately 2 to 4 weeks to kill all fleas.

PRECAUTIONARY STATEMENTS:

Harmful if swallowed or inhaled. Causes moderate eye irritation. Avoid breathing dust. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash clothing before reuse.

STATEMENT OF PRACTICAL TREATMENT:

IF IN EYES: Flush with plenty of water. Call a physician if irritation persists.

IF SWALLOWED: Call a physician or Poison Control Center. Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. If person is unconscious, do not give anything by mouth and do not induce vomiting.

IF INHALED: Remove victim to fresh air. If not breathing, give artificial respiration, preferably mouth-to-mouth. Get medical attention.

STORAGE AND DISPOSAL: Keep container closed when not in use. Do not contaminate water, food, or feed by storage or disposal. Store in a cool dry place. Do not store where children or animals may gain access.

DISPOSAL: Do not reuse empty container. Securely wrap original container in several layers of newspaper and discard in trash.
