

Subject: Albchem Sodium Chlorate EPA Registration Number 65170-1 Amendment Dated September 28, 2003

The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act as amended is acceptable, provided you make the following changes before you release the product for shipment.

1) Under Personal Protective Equipment (PPE) change rubber gloves to chemical resistant gloves made of any waterproof material, change rubber boots to chemical-resistant footwear, change googles or safety glasses to protective eyewear, and add long pants and long-sleeved shirt.

2) Remove "Always remove and wash contaminated clothing before reuse" from under Precautionary Statements.

3) Move "Prolonged or frequently repeated skin contact may cause allergic reaction in some individuals" from User Safety Recommendations to under Precautionary Statements

4) Add "Do not give anything by mouth to an unconscious person" to If Swallowed statement under FIRST AID.

5) Change the Ingredient Statement format so that the headings "ACTIVE INGREDIENT" and "INERT INGREDIENT" (or the plural forms of these terms) must be the same type size, aligned to the same left margin and equally prominent, and change the TOTAL of 100% to 100.0%

6) Specify uses for which this product may be repacked or formulated into end use products. The uses specified must conform to uses for which you have satisfied your data compensation obligations.

Submit three (3) copies of final printed labeling incorporating the above changes before you release the product for shipment. Amended labeling will supercede all previously accepted ones. A stamped copy of labeling is enclosed for your records.

## PRECAUTIO ARY STATEMENTS

#### DANGER

#### HAZARDS TO HUMANS AND DOMESTIC ANIMALS

May cause skin and eye irritation. May be fatal if swallowed. Do not get in eyes, on skin or on clothing. This pesticide is toxic to fish and aquatic organisms. Do not discharge effluent containing this product into lakes, streams, ponds, estuaries, oceans or other waters unless in accordance with the requirements of a National Pollutant Discharge Elimination System (NPDES) permit and the permitting authority has been notified in writing prior to sewage discharge. Do not discharge effluent containing this product to sewer systems without previously notifying the local sewage Board or Regional Office of the EPA.

#### PHYSICAL AND CHEMICAL HAZARDS

Strong oxidizing agent: Mix only with water. Use clean dry utensils and packaging designed for Sodium Chlorate. Do not add this product to any dispensing device containing remnants of any other product. Such use may cause a violent reaction leading to fire and/or explosion. Contamination with organics, combustible materials, reducing agents, ammonia salts, foodstuffs, oils, solvents, lint, leather, powdered metals will start a chemical reaction and generate heat and oxygen and result in fire and/or explosion. Avoid contact with acids or low pH solutions as well as other incompatible materials, because they are readily ignited by heat, shock or friction. In case of contamination, do not reseal container. If possible, promptly isolate container in open air or well ventilated area. Flood area with large volumes of water. Water is the orly effective fire fighting agent.

#### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

#### STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

**PESTICIDE STORAGE:** Sodiam Chlorate should be stored in tightly closed container when not in use. Product must be stored in approved packaging in a dry cool location and away from all heat sources as well as away from all possible incompatible contaminants that may initiate a decomposition reaction.

PESTICIDE DISPOSAL: Wastes resulting from the use of this product may be disposed on-site or at an approved waste disposal facility. Improper disposal of excess pesticide, spray mix or rinsate is a violation of Federal law. If these wastes cannot bed disposed by use according to label instruction, contact your State Pesticide or Environmental Control Agency, or the Hazardous Waste representative at the nearest EPA Regional Office for guidance.
