- e. In the Directions change all references to "insects and ticks" to read "mosquitoes and deer ticks".
- f. In the Directions, the claim for mosquitoes must be qualified by the statements " Effectivness lasts for up to one hour. and Reapply when effectivness diminishes ". The data for mosquitoes demonstrated effectivness for only up to one hour.
- g. In the ingredients statement on the front panel change the statement "Inert Repellent Ingredients" to read "Inert Ingredients."

3. Submit one (1) copy of the revised final printed label for the record.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.
