

**Citruscreen Citronella Bug Repellent**

Citruscreen citronella bug repellent provides complete dual protection for your skin from both the sun and insects. This unique SPF 27 formulation provides all-day-long, sun protection from harmful UVA/UVB rays, and it is also waterproof. Citruscreen bug repellent provides protection from mosquitoes, fleas, and ticks, and combines specially blended moisturizers with Aloe and Vitamin E to protect delicate skin from drying, chafing, chapping, cracking or windburn.

**Directions:** It is a violation of Federal Law to use this product in a manner inconsistent with its labeling. Apply Citruscreen liberally and evenly at least 15 minutes prior to exposure to the sun, mosquitoes, deer ticks and fleas. Smooth in until completely absorbed. For continued mosquito, deer tick and flea protection, reapply about every two hours or sooner if effectiveness diminishes. For continued sunscreen protection, reapply after 80 minutes in the water, excessive perspiration, prolonged activity or towel drying. For continuing skin protection, apply liberally as often as necessary.

**Dispose:** Do not reuse empty container. Put in trash.

**Precautionary Statements:** For external use only. Do not swallow. Avoid contact with eyes. Protect from freezing. Discontinue use if irritation or rash appears. Not to be applied over deep or puncture wounds, infections or lacerations. Consult a physician before using on children under six months of age. Keep this and all drugs out of the reach of children.

**First Aid: If in eyes:** Hold eyes open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call Poison Control Center or doctor for treatment advice. In case of accidental ingestion, seek professional assistance or contact a poison control center immediately. If irritation or rash persists or a skin condition worsens or does not improve within 7 days, consult a physician.

**Active Ingredients:** Octocrylene 9% w/w, oxybenzone 6% w/w, octyl methoxycinnamate 7.5% w/w, octyl salicylate 4% w/w, dimethicone 1% w/w.
