

FIRST AID

How to unlock the trigger pump: Press down on lock button located at the top of the trigger pump. At the same time, rotate the nezzle counterclockwise one full turn so that the tab on the lock button aligns with the notch in the nozzle. To lock the trigger pump, reverse the process. The trigger pump should be left in the locked position when not in use.

Wear household latex groves. Hold bottle in upright position. Ruffle the animal's coat with one hand while applying spray mist to the animal's back, sides, abdomen, legs, shoulders and neck. For head and eye area, spray FRONTLINE® Spray on a gloved hand and rub gently into animal's hair. Do not get this product in you pet's eyes or mouth.

Apply spray mist until animal's hair is damp to thoroughly wet.

Approximately 1 to 2 pumps per pound of the animal's body weight will be required. Pets with long or dense coats will require the higher rate.
