DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Use Restrictions: Children and pets should not be in treatment areas until after application is complete. Avoid contamination of food and feed stuff.

Hot Water (Steam Injection) Method:

- Flea X-1 is designed to be used in hot water (steam) injection carpet equipment.
- Dissolve one cup (4 oz. net weight) of Flea X-1 powder in each gallon of water or detergent solution. Apply to carpets as directed by the equipment manufacturer.
- DO NOT clean carpets and then, while the carpet is still wet, treat for fleas separately. This will cause saturation of the carpet.
- One cup (4 oz.) of Flea X-1 in solution will treat 75 - 120 square feet of carpet depending on the length and thickness of the pile.

Dry Powder Application Method:

- Sprinkle one cup (4 oz. net weight) of Flea X-1 powder evenly over 75 - 120 square feet of carpet area.
- Gently work powder into dry carpet using a brush with soft bristles. (NEVER APPLY DRY POWDER TO WET CARPETS.)
- Any powder visible after application must be brushed into carpet fibers or removed.
- Do not vacuum carpet for 48 hours.
- Each pound of Flea X-1 powder will treat 300-480 square feet of carpet depending on length and thickness of pile.

Directions for Use:

- Do not use in edible product areas of food processing plants or on counter tops and other surface areas where food is prepared. Do not use in serving areas while food is exposed.

Mixing and Application Directions (Cockroaches and Silverfish):

- Add one cup of powder (4 oz.) to each pail of mop or rinse water (5 gal.). SMAK for Roaches dissolves instantly in water. **Apply to floor areas only.** Make only enough for each application. Designed for use as a supplemental treatment to exterminating service. **Avoid contamination of feed and foodstuffs.** Use daily in areas with severe infestation. In normal use, apply daily for 10-15 days and then every other day thereafter to maintain residual. If use is discontinued for a week, use daily for 10 days thereafter to rebuild residual.

Food areas and Food Serving Areas:

Apply only when food is not exposed and facility is not in operation. Avoid treating surfaces likely to be contacted by food

Storage and Disposal:

Do not contaminate water, food or feed by storage or disposal.

STORAGE: Store in a dry place. Store in original container away from food and feed stuffs. Do not store where children or animals may gain access. Keep product in locked storage area.

PESTICIDE DISPOSAL: Wastes resulting from the use of this product may be disposed on site or at an approved waste disposal facility.

CONTAINER DISPOSAL: When container is empty, securely wrap original container in several layers of newspaper and discard in trash.
