You may remove the phrase "use just enough repellent to cover exposed skin and/or clothing."
- f. The signal word for this product should be "Caution". Please change the signal word to caution on both the front panel and in the Precautionary Statements section. Revise the statement in the Precautionary Statements section "May cause eye injury." to the statement "Avoid contact with eyes and lips."
- 3. Please submit a revised Confidential Statement of Formula which shows EPA Reg. No. 3095-23 as the source product and breaking down the consistuant parts (as you have done) without identifying McLaughlin Gormley King Co. as the registrant. Your source is PIC Corp., not MGK.
