The amended label and CSF(s) referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, are acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. Pursuant to 40 CFR 156.10(a)(6) you must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.



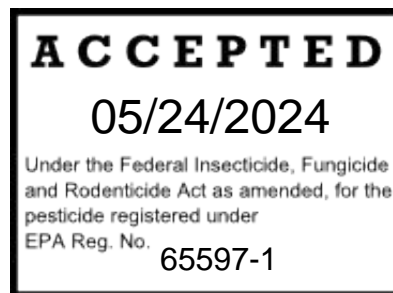

Triple rinse as follows: Empty the remaining contents into the fuel system and drain for 10 seconds after the flow begins to drip. Fill the container 1/4 full with fuel and recap. Shake for 10 seconds. Pour rinsate into the fuel system. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times. Then offer container for recycling if available or puncture and dispose of in a sanitary landfill, or by incineration.

[For containers larger than 5 gallons:]

Completely empty the remaining contents into the fuel system. Recap the container then offer empty container to a Hazardous Waste Disposal Facility for reconditioning or recycling.

FUEL PRESERVATIVE: FQS 1.5 Microbicide® is recommended for the control of bacteria and fungi in fuel systems that use or store liquid hydrocarbon fuels and oils, for example crude oils, petrochemical feedstocks, liquefied petroleum gases, gasoline, aviation fuels, kerosene, diesel fuel oils, fuel oils; heating oil, residual fuel oils, coal slurries, renewable fuel blend stock and renewable fuel blends.

METHOD OF ADDITION: FQS 1.5 Microbicide® should be directly dispensed into a fuel tank, storage tank, or flowing stream of fuel in a manner to ensure uniform distribution of the preservative in the fuel system. Slug dose or continuous feed methods are recommended.

DOSE RATE: When microbial contamination is detected, add FQS 1.5 Microbicide® in order to achieve and maintain a final system concentration of 100-400 parts per million (v/v) volume to volume. For example, this can be accomplished by adding:
