

APPLICATION DIRECTIONS:
Shake container thoroughly before using. DO NOT SPRAY INTO WIND. Position yourself so that wind is to your back. Point sprayer away from face. Spray liberal amount of product around pest's food source and all possible routes to it. For best results on plants spray both sides of leaves. Reapply as necessary. May take several days to teach rabbits not to feed at treated areas.

Storage: Store only in original container in dry place inaccessible to children or pets.
Disposal: Do not reuse empty container. Rinse thoroughly. Securely wrap in newspaper and discard in trash.
