

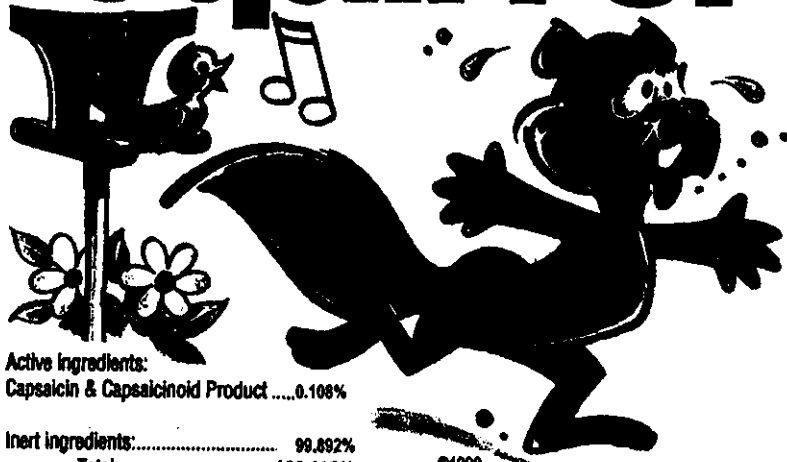

APPLICATION DIRECTIONS:

Shake container thoroughly before using. DO NOT SPRAY INTO WIND. Position yourself so that wind is to you back. Point sprayer away from face. Spray liberal amount of product around feeder base and all possible routes to feeder including pole, feeder and seed. Product will not harm birds. Reapply as necessary. May take several days to teach squirrels not to feed at treated feeder.

STORAGE AND DISPOSAL

Storage: Store only in original container in dry place inaccessible to children or pets.

Disposal: Do not reuse empty container. Rinse thoroughly. Securely wrap in newspaper and discard in trash.
