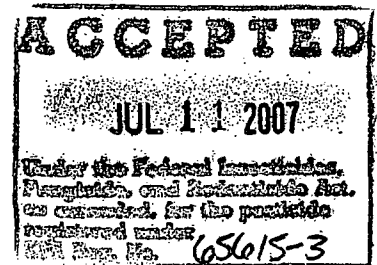

## Squirrel Repellent

**APPLICATION DIRECTIONS:** DO NOT SPRAY INTO THE WIND. Position yourself so the wind is to your back. Point sprayer away from face. Spray liberal amount of product three feet around the feeder base and all possible routes to feeder including pole and feeder; do not spray on seed as it will make seeds harder for birds to crack. Product will not harm birds. To prevent cats from using your flower beds as a litter box treat soil where cat is digging. For dogs in garbage spray around garbage can or bag plus inside bag or can. Do not spray on handles or where you will be handling bag. Reapply as necessary, may take several days to teach animals not to frequent treated areas.
