DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

To Kill Fleas, Lice and Ticks: Dilute 2 fluid ounces (4 tablespoons), with one gallon of water. Use rubber gloves. Work in well ventilated area. Dip animal in solution, making sure hair is thoroughly wet to the skin. The area around the ears should be sponged thoroughly. Avoid contact of material with eyes and mouth of animal. Dipping should not exceed 30 seconds. Allow animal to dry in warm place without rinsing or toweling. Repeat application every two weeks or as necessary.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

STORAGE: Store in cool area away from heat or open flame.

PESTICIDE STORAGE AND SPILL PROCEDURES: Store upright at room temperature. Avoid exposure to extreme temperatures. In case of spill or leakage, soak up with an absorbent material such as sand, sawdust, earth, fuller's earth, etc. Dispose of with chemical waste.

PESTICIDE DISPOSAL: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

CONTAINER DISPOSAL: Triple rinse (or equivalent) then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or by other approved state and local procedures.

CONTAINERS ONE GALLON AND SMALLER: Do not reuse container. Wrap and discard in trash.
