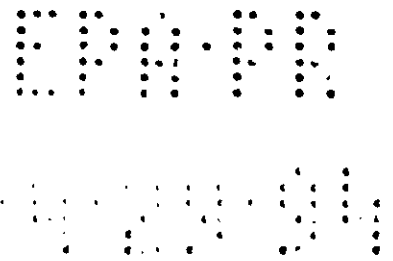

**To kill Fleas, Lice and Ticks:** Dilute 2 ounces of concentrate with 1 gallon of warm water. Dip, sponge or swab animal with diluted solution, making sure hair is thoroughly wet to the skin. Area around the ears should be sponged thoroughly. Avoid contact of material with eyes and mouth. Allow pet to dry in a warm place without rinsing or toweling. Repeat as necessary for control.

## STORAGE AND DISPOSAL
