WAIT 30 MINUTES THEN VACUUM. Sprinkle only over areas that can be vacuumed. IF TICKS ARE PRESENT, LEAVE POWDER ON SURFACE FOR TWO HOURS. Avoid use on wet spots. If product adheres to spot, rub with stiff brush and vacuum.

STORAGE: Store in cool, dry place.

DISPOSAL: Do not re-use container. Wrap and put in trash.
