Under the Federal Insecticide, Fungicide, and Rodenticide Act as amended, for the pesticide registered under EPA Reg. No. 65636-63

Spray the animal from a distance of 8-12 inches. Start spraying at the tail, moving the dispenser rapidly and making sure the animal's entire body is covered, including the legs and under the body. Fluff the hair as you spray so the spray will penetrate to the skin. The spray should wet the ticks thoroughly. Do not spray in face, eyes or on genitalia. Repeat as needed.

**STORAGE AND DISPOSAL**

**Storage:** Store in a cool area away from heat and open flame. Store above 32°F and protect from freezing.

**Disposal:** Do not re-use container. Wrap and discard in trash.
