

**Shake Well Before Using**

**For use on carpets\*:** hold upside down and shake powder evenly across surface. Brush lightly with a broom and allow powder to penetrate carpet fibers. Wait 60 minutes, then vacuum. For severe problems or where ticks are known to be hiding, wait 2 to 3 hours before vacuuming. If powder adheres to a spot, brush it out and vacuum immediately. Apply to dry surfaces only. Do not allow powder to become wet.

**For use on upholstery\*:** remove all loose cushions. Sprinkle along creases in corners. Brush gently, wait 60 minutes, vacuum. Sprinkle along underside of furniture. Do not use on exposed fabric; may cause staining. Remove bag from vacuum cleaner. Wrap securely in several layers of newspaper and discard in trash.
