Each application remains active in the coat, killing fleas and protecting against reinfestation for up to one month after spraying. Protects against ticks for up to 21 days. Repeat treatment as necessary. Old bedding of pets should be removed and replaced with clean, fresh bedding after treatment of pet areas.

STORAGE AND DISPOSAL

Storage: Store in a cool, dry area away from heat or open flame. Protect from freezing.

Disposal: Do not re-use container. Wrap and put in trash.

PRECAUTIONARY STATEMENTS

Hazards to Humans and Domestic Animals

CAUTION

Harmful if swallowed. Avoid contact with eyes, skin or clothing. Do not breathe spray mist. Do not contaminate food, feedstuffs or water supplies. Do not use on cats. Do not use on nursing puppies, or pups under 10 weeks old.

STATEMENTS OF PRACTICAL TREATMENT

If Swallowed: Call a physician or Poison Control Center. Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. Do not induce vomiting or give anything by mouth to an unconscious person.

If On Skin: Wash thoroughly with soap and water.

If In Eyes: Flush with plenty of water. Get medical attention if irritation persists.

Note To Physician: Chlorpyrifos is a cholinesterase inhibitor. Treat symptomatically. Atropine by injection is antidotal only if symptoms of cholinesterase inhibitor is present.
