of Dip Concentrate into one (1) gallon of water. Use rubber
gloves. Dip, sponge or swab dog with the emulsion until thoroughly
wet. Avoid allowing dip to enter dog's nose or mouth. Dipping
should not exceed 30 seconds. Allow dog to dry in warm place
without rinsing or toweling. Kills fleas, ticks and mites on
contact, but may require 24-48 hours to kill engorged ticks.
Repeat application in 21 day intervals as necessary.**
