DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

For Control of Fleas, ticks and lice: Dust pet liberally by rubbing dust into animal's hair. Begin at tail and work toward the head. Take care not to get dust in animal's eyes, nose or mouth. Be sure to dust paws and between toes. Dust bedding, kennels and sleeping quarters regularly. Apply at least once a week for best results.

Do Not Use On Pregnant Dogs.

STORAGE AND DISPOSAL

Storage: Store in a cool dry place. Keep cap closed tightly.

Disposal: Do not reuse container. Wrap and put in trash.

This container is sold by weight, NOT by volume. You can be assured of the proper weight even though some settling of contents normally occurs during transportation and handling.

CAUTION

Avoid breathing of dust when you apply powder. May be harmful if swallowed. Avoid contact with eyes, skin or clothing. Wash thoroughly after handling. Do not treat puppies and kittens under 4 weeks of age. Keep out of reach of children.

Notice to Physician: Carbaryl is a moderate reversible cholinesterase inhibitor. Atropine sulfate is antidotal.
