


**To Kill Fleas, Ticks and Lice:** Bathe pet with a quality cleaning shampoo. Dilute 4 ounces of dip concentrate with 1 gallon of water. Dip animal into solution, making sure hair is wet to the skin. The area around the ears should be sponged thoroughly. Avoid contact of material with eyes and mouth of animal. Do not rinse off. Repeat as necessary for control.
