To Kill Fleas, Ticks and Lice: Bathe pet with a quality cleaning shampoo. Dilute 4 ounces of dip concentrate with 1 gallon of water. Dip animal into solution, making sure hair is wet: to: the skin. The area around the ears should be sponged thoroughly..... Avoid contact of material with eyes and mouth of animal. Do not rinse off. Repeat as necessary for control.

#### STORAGE AND DISPOSAL

Storage: Store in a cool area away from heat or open flame.


