DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

This Spray kills fleas and ticks. It contains a unique combination of ingredients that kills both adult and preadult fleas. Even kills fleas before they grow up to bite. An Insect Growth Regulator (IGR) ingredient in this flea spray, continues to kill fleas for 120 days (4 months) by preventing their development into the adult biting stage. It reaches fleas hidden in carpets, rugs, drapes, upholstery, pet bedding, floor cracks. Protects your home from reinfestation and flea build-up, and your pets and family from bites. One treatment with this spray gives continuous flea protection for 120 days. Leaves no objectional odor or sticky mess and, used as directed, does not stain furnishings.

SHAKE WELL BEFORE EACH USE

FLEAS AND TICKS: Hold bottle 2 to 3 feet from surfaces to be treated. Apply uniformly using a sweeping motion to carpets, rugs, drapes and all surfaces of upholstered furniture. Be sure to treat pet bedding, as this is a primary Kiding place for fleas. No need to remove pet bedding after treatment.

DO NOT TREAT PETS. Use an EPA registered flea and tick control product on your pets in conjunction with this treatment. Retreat as necessary. Avoid wetting furniture and carpeting. A fine mist or spray applied uniformly is all that is necessary to kill fleas and ticks.

STORAGE & DISPOSAL

STORAGE: Store in a cool, dry place inaccessible to children. Keep container closed.

DISPOSAL: Do not reuse container. Wrap and discard in trash.
