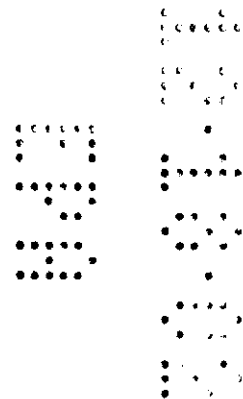

Alpha 3 Roach Bait may be used as a spot or crack and crevice treatment for the control of cockroaches, in residential areas and in the non food and non feed areas of institutional, warehousing and commercial establishments, including warehouses, restaurants, food processing plants, supermarkets, hospitals, nursing homes, motels hotels, schools, laboratories, computer facilities, sewers, ~~aircraft~~ buses, boats/ships, trains, pets shops, and zoos. Non food and feed areas are areas such as garbage rooms lavatories, floor drains (" to sewers") entries, and vestibules, offices locker rooms, machine rooms, boiler rooms, garages, mop closets, and storage rooms. During follow up visits, inspect bait placements and reapply when necessary. This product may be used in food and feed handling establishments as outlined below.

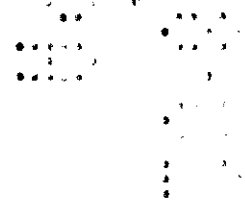
General Precautions and Restrictions

Children and pets should not be in treatment area until after application is completed. Do not treat pets with this product. Avoid contamination of feed and foodstuff. Avoid contamination of ornamental plants.

APPLICATION OF THIS PRODUCT IN THE FOOD AND FEED AREAS OF FOOD HANDLING ESTABLISHMENTS OTHER THAN AS A CRACK AND CREVICE TREATMENT, IS NOT PERMITTED.

DIRECTIONS FOR APPLYING ALPHA 3 ROACH BAIT IN NEW CONSTRUCTION TO CONTROL COCKROACHES: When treating large areas, such as wall voids, soffit and cabinet voids and areas around utility openings in new and existing construction, apply bait liberally into cracks and crevices. This product may be used in homes, restaurants and other feed and food handling establishments, markets, warehouses factories, offices, schools, motels, hotels, nursing homes, hospitals, grocery stores, garages, apartment buildings, new constructions, theaters, ships/boats, aircraft, industrial plants, mobile homes, zoos, kennels, military bases, libraries and utilities.

CRACK AND CREVICE TREATMENT, FOOD AND FEED HANDLING ESTABLISHMENTS: Places other than private residences on which exposed food or feed is held, processed, prepared or served.

ALPHA 3 ROACH BAIT is packaged in a plastic reservoir containing (1.0 oz) of bait. Application rate is dependent on the level of infestation and the species to be controlled. Bait can be applied as spots or as a bead in cracks and crevices. The lower application rate should be used for low to moderate infestations or re-treatments and the higher rate for more severe infestations or where the population occurs in inaccessible areas, such as in walls. Bait placements should be at or near harborage or aggregation areas, such as corners, areas of movement or cracks and crevices. Numerous smaller placements will provide faster control than fewer larger spots especially for German cockroach control.
