DIP-DIFFUSION METHOD OF APPLICATION: Dip freshly-cut tumber in a tank containing a hot aqueous solution of ENVIROTECH™WP for 2 to 5 minutes. After dipping, the newly treated wood should be stacked and stored under a tarpaulin or shed roof to slow the drying process and prevent washoff by rainfall, thus improving penetration.
