. These Act 90 tablets were manufactured for use in erosion type feeders, where they are slowly dissolved as the water flows over the tablets surface. If thrown directly into water, Act 90 tablets may stain concrete or vinyl walls.

. 24 hours after filling the chlorinator, check the water with a test kit for chlorine availability. If necessary, adjust the feeder so that the available chlorine is always maintained between 1.0 to 2.0 ppm.

SUPERCHLORINATION. Superchlorination is necessary at the sta bathing season. Upon filling the pool, every week during ho and following heavy rains. Superchlorination is performed two to three times the normal amount of chlorine to oxidize a unwanted organic and inorganic material. A granular chloring which will dissolve quickly, should be used for superchlo Follow the directions for use found on the granular product for superchlorination use. Bathers should not be permitted the pool during superchlorination until the chlorine residua than 3.0 ppm.

The pH should be maintained between 7.2 and 7.6.

Use pool only when the chlorine residual is between 1.0 - 3.0

Frequency of treatment, and dosage is dependent on temperature and bather load.
