Starting one row down from roof cap, install from either end of the roof — slide one Shingle Shield under shingle until its built-in alignment guide butts against the edge of the overlapping shingle.

Once aligned, raise shingle tab, locate a pre-punched hole and nail into place using neoprene washer head roofing nails (not included). Repeat process with a 1/8" gap between each Shingle Shield until row is completed.

Storage and Disposal

Do not reuse empty container. Wrap container and place in trash.
