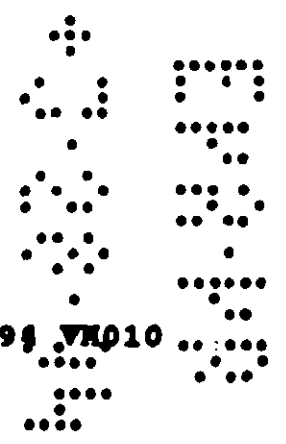

**DIRECTIONS FOR USE**

It a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Apply spray until area is wet, but not to the point of run-off. Repeat as necessary.

For indoor use in the non-food areas of hotels, motels, homes, dog kennels, preschools, apartments, commercial, office, institutional, storage, and recreational buildings.

**FLEAS, BROWN DOG AND LONE STAR TICKS:** Thoroughly apply as spot treatment to infested areas such as pets' beds and resting quarters; nearby cracks and crevices; along and behind baseboards, window and door frames and localized areas of floor and floor covering where these pests may be present. Old bedding of pets should be removed and replaced with clean fresh bedding after treatment of pet areas. **DO NOT TREAT PETS WITH THIS PRODUCT.** Treat pets with a product registered for animal application.

**RESIDUAL SPRAY: AIDS IN THE CONTROL OF COCKROACHES (Waterbugs), CRICKETS, BOXELDER BUGS, SCORPIONS, SPIDER BEETLES, SILVERFISH (Firebrats), CENTIPEDES, MILLIPEDES, EARWIGS, SOWBUGS (Pillbugs).** Kills up to 4 weeks. 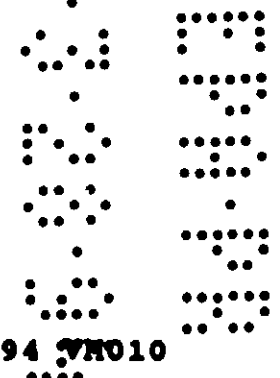
**STORAGE AND DISPOSAL**

**IF INHALED:** Remove victim to fresh air. Apply artificial respiration if indicated.

**IF ON SKIN:** Remove contaminated clothing and wash affected areas with soap and water.

**IF IN EYES:** Flush eyes with plenty of water. Call a physician if irritation persists.

**NOTE TO PHYSICIAN:** Chlorpyrifos is a cholinesterase inhibitor. If symptoms of cholinesterase inhibition appear, atropine only by injection is an antidote.
