This technical-grade product may be used in end-product insecticides, such as trap-and-kill, for control of Mediterranean Fruit Fly (*Ceratitis capitata*) if the formulator, user group or grower has complied with U.S. EPA submission requirements regarding the support of such use(s). The end-product may only be formulated into polymeric-matrix removable dispensers as described in 40 CFR 180.1124.

The end-product may be used to control the Mediterranean Fruit Fly on infested fruit crops, nut crops and vegetable crops.

FOR USE IN TRAPS AND LURES

This technical-grade product may be used in traps and lures without further registration requirements when it is the only active ingredient in accordance with 40CFR 152.25(b).

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.
