MUSHROOM HOUSES

Mushroom flies (PHORIDS and SCIARIDS): Mix 4 to 5 lbs. of product in 50 gals. of water and spray on outside and inside walls, floors, and sideboards of mushroom houses after compost has been pasturized by heating.
