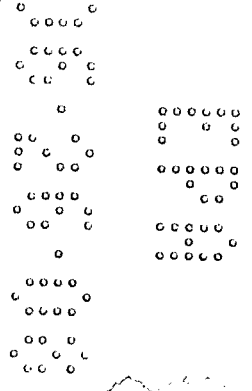

GENERAL INFORMATION (continued)

Use around the home, the business, or workplace where no plant growth is desired. Pramitol 1.8 L is intended for bare ground vegetation control in driveways, sidewalks, brick walks, paths, patios, parking areas, play areas, along fences and curbs, around buildings, and under graveled pathways where plant growth has come through these surfaces. The product should be diluted with water before application.

Do not use on lawns, flower beds, or vegetable gardens. Pramitol 1.8 L should not be applied over the root zones of desirable trees or shrubs. Do not apply in sloped areas where runoff may adversely affect desirable plants.

Although Pramitol 1.8 L has considerable activity through foliar contact, much of its activity is through roots; therefore, **its effectiveness is dependent on rainfall to move it into the root zone. Very dry soil conditions and lack of sufficient rainfall may result in poor weed control.** For best results, if the soil is dry, water lightly before treatment. Apply Pramitol 1.8 L directly to weeds and grass. Thoroughly wet weeds but do not soak as runoff may occur. Two days following application, lightly water the treated area. This will aid in the killing and prevention of weeds through root absorption.

When an adjuvant is to be used with this product, Makhteshim Agan of North America, Inc. suggests the use of a Chemical Producers and Distributors Association certified adjuvant.

WHEN TO APPLY

For best results, apply to bare ground or when weed growth is just starting. Weeds taller than 4 inches should be hoed or cut to 1-inch in height before treatment or it may be necessary to make a second application. A second application may also be necessary to control deep-rooted perennial weeds. In areas of heavy rainfall, repeat applications may be required every six months.

HOW TO APPLY

For control of annual and susceptible perennial weeds, use the lower rates listed below. For control of hard-to-kill perennial broadleaf and grass weeds, use the higher rates listed below.

Apply ONLY with a sprinkling can unless applying this product in remote locations where possible drifting is NOT a concern; then a plastic tank sprayer may be used in lieu of the sprinkling can. When using a sprinkling can, triple rinse and pour rinsate on area treated once application is complete. Mix only the quantity needed and use immediately. **Do not use a hose-end sprayer.**

For best results, apply Pramitol 1.8 L to contact and absorb into surface weeds. To prevent growth of weeds under asphalt driveways, parking areas or tennis courts, and play areas, apply Pramitol 1.8 L to excavated areas and saturate soil, BEFORE surface areas are finished.

IMPORTANT: To avoid damage to desirable plants, apply when it is not windy. Windy conditions may cause inadvertent drifting to desirable plants. DO NOT apply over the root zones of desirable trees and shrubs. DO NOT apply to decorative rock or bark groundcovers where the soil is covered with plastic fabric or runoff and/or leaching may result. In heavy clay soil locations, residual activity may exceed one year. DO NOT apply where plantings are planted. DO NOT apply closer than twice the distance from the trunk to the drip line. DO NOT apply next to a fence if desirable plants are growing on the other side or if future plantings are planned. Vertically cut through any roots adjacent to root zone of desirable plants. Also follow the precautions listed below.

USE PRECAUTIONS:

1. Apply when air is calm to avoid the possibility of drift onto desirable plants or grass.
2. Keep away from the roots of desirable plants and trees.
3. Use only in areas where complete control of all vegetation is desired.
4. **Pramitol 1.8 L should not be used on cultivated areas, on ground that is to be cultivated, in greenhouses, or near the drip line of trees or shrubs.**
5. Do not use on slopes or in areas where runoff is likely to occur (apply only to level surfaces).
6. Avoid using where adjacent desirable trees, shrubs, or plants may be injured from leaching of the chemical through the soil.
7. Keep children and animals off treated areas until these areas are dry.

Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. Place in trash or offer for recycling if available.

Refillable Container: Refillable container. Refill this container with prometon only. Do not reuse this container for any other purpose.
