Very dry soil conditions and lack of sufficient rainfall may result in poor weed control. For best results, if the soil is dry, water lightly before treatment. Apply Pramitol 2.2L directly to weeds and grass. Thoroughly wet weeds but do not soak as runoff may occur. Two days following application, lightly water the treated area. This will aid in the killing and prevention of weeds through root absorption.

WHEN TO APPLY

For best results, apply to bare ground or when weed growth is just starting. Weeds taller than 4 inches should be hoed or cut to 1 inch in height before treatment or it may be necessary to make a second application.
