GENERAL INFORMATION

Pramitol 2.2L is a nonselective product intended for use after dilution with water and will kill almost all vegetation down to the roots and prevent plant regrowth. When applied to the soil, this product can inhibit plant growth for up to one year. Residual control increases as rates are increased. Use around the home, the business, or workplace where no plant growth is desired. Pramitol 2.2L is intended for bare ground vegetation control in driveways, sidewalks, brick walks, paths, patios, parking areas, play areas, along fences and curbs, around buildings, and under graveled pathways where plant growth has come through these surfaces. **[Note to label editor: when alternate language about FOR RESIDENTIALHOUSEHOLD USE ONLY is used, delete reference to ...the business, or workplace... above.]**

Do not use on lawns, flower beds, or vegetable gardens. Pramitol 2.2L should not be applied over the root zones of desirable trees or shrubs. Do not apply in sloped areas where runoff may adversely affect desirable plants.

Although Pramitol 2.2L has considerable activity through foliar contact, much of its activity is through roots; therefore, **its effectiveness is dependent on rainfall to move it into the root zone. Very dry soil conditions and lack of sufficient rainfall may result in poor weed control.** For best results, if the soil is dry, water lightly before treatment. Apply Pramitol 2.2L directly to weeds and grass. Thoroughly wet weeds but do not soak as runoff may occur. Two days following application, lightly water the treated area. This will aid in the killing and prevention of weeds through root absorption.

When an adjuvant is to be used with this product, Makhteshim Agan of North America, Inc. suggests the use of a Chemical Producers and Distributors Association certified adjuvant.

WHEN TO APPLY

For best results, apply to bare ground or when weed growth is just starting. Weeds taller than 4 inches should be hoed or cut to 1 inch in height before treatment or it may be necessary to make a second application. A second application may also be necessary to control deep-rooted perennial weeds. In areas of heavy rainfall, repeat applications may be required every six months.

For control of annual and susceptible perennial weeds, use the lower rates listed below. For control of hard-to-kill perennial broadleaf and grass weeds, use the higher rates listed below.

Apply using a sprinkling can or other watering or spraying device in sufficient water to get good coverage of the area (refer to suggested amount of water to use in above table). When using a sprinkling can, triple rinse and pour rinsate on area treated once application is complete. Mix only the quantity needed and use immediately. Do not store diluted solution once container is opened.

IMPORTANT: To avoid damage to desirable plants, apply when it is not windy. Windy conditions may cause inadvertent drifting to desirable plants. DO NOT apply over the root zones of desirable trees and shrubs. DO NOT apply to decorative rock or bark groundcovers where the soil is covered with plastic fabric or runoff and/or leaching may result. In heavy clay soil locations, residual activity may exceed one year. DO NOT apply where plantings are planted. Do not apply closer than twice the distance from the trunk to the drip line. Do not apply next to a fence if desirable plants are growing on the other side or if future plantings are planned. Vertically cut through any roots adjacent to root zone of desirable plants. Also follow the use precautions listed below.

USE PRECAUTIONS:

1. Apply when air is calm to avoid the possibility of drift onto desirable plants or grass.
2. Keep away from the roots of desirable plants and trees.
3. Use only in areas where complete control of all vegetation is desired.
4. **Pramitol 2.2L should not be used on cultivated areas, on ground that is to be cultivated, in greenhouses, or near the drip line of trees or shrubs.**
5. Do not use on slopes or in areas where runoff is likely to occur (apply only to level surfaces).
6. Avoid using where adjacent desirable trees, shrubs, or plants may be injured from leaching of the chemical through the soil.
7. Keep children and animals off treated areas until these areas are dry.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.
