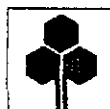

### GENERAL INFORMATION

Pramitol RTU will kill almost all vegetation down to the roots and prevent plant regrowth. When applied to the soil, this product can inhibit plant growth for up to one year. Use around the home, the business, or workplace where no plant growth is desired. Pramitol RTU is intended for bare ground vegetation control in driveways, sidewalks, brick walks, paths, patios, parking areas, play areas, along fences and curbs, around buildings, and under graveled pathways where plant growth has come through these surfaces. This product is intended for use without dilution.

Do not use on lawns, flower beds, or vegetable gardens. Pramitol RTU should not be applied over the root zones of desirable trees or shrubs. Do not apply in sloped areas where runoff may adversely affect desirable plants.

Although Pramitol RTU has considerable activity through foliar contact, much of its activity is through roots; therefore, **its effectiveness is dependent on rainfall to move it into the root zone. Very dry soil conditions and lack of sufficient rainfall may result in poor weed control.** For best results, if the soil is dry, water lightly before treatment. Apply Pramitol RTU directly to weeds and grass. Thoroughly wet weeds but do not soak as runoff may occur. Two days following application, lightly water the treated area. This will aid in the killing and prevention of weeds through root absorption.

### WHEN TO APPLY

For best results, apply to bare ground or when weed growth is just starting. Weeds taller than 4 inches should be hoed or cut to 1-inch in height before treatment or it may be necessary to make a second application. A second application may also be necessary to control deep-rooted perennial weeds. In areas of heavy rainfall, repeat applications may be required every six months.

### HOW TO APPLY

For control of weeds, use the rates listed in the table below.

Area to be Treated	Amount to Use
25 sq. ft.	2 pts.
50 sq. ft.	4 pts.
75 sq. ft.	6 pts.
100 sq. ft.	8 pts.

Apply ONLY with a sprinkling can unless applying this product in remote locations where possible drifting is NOT a concern; then a plastic tank sprayer may be used in lieu of the sprinkling can. When using a sprinkling can or plastic tank sprayer, triple rinse and pour rinsate on area treated once application is complete. Measure out only the quantity needed for the area to be treated and use immediately.

For best results, apply Pramitol RTU so it can contact and be absorbed into target weeds and surrounding soil. To prevent growth of weeds under asphalt driveways, parking areas or tennis courts, and play areas, apply Pramitol RTU to excavated areas and saturate soil BEFORE surface areas are finished.

**IMPORTANT:** To avoid damage to desirable plants, apply when it is not windy. Windy conditions may cause inadvertent drifting to desirable plants. DO NOT apply over the root zones of desirable trees and shrubs. DO NOT apply to decorative rock or bark groundcovers where the soil is covered with plastic fabric or runoff and/or leaching may result. In heavy clay soil locations, residual activity may exceed one year. DO NOT apply where plantings are planned. Do not apply closer than twice the distance from the trunk to the drip line. Do not apply next to a fence if desirable plants are growing on the other side or if future plantings are planned. Vertically cut through any roots adjacent to root zone of desirable plants. Also follow the precautions listed below.

### PRECAUTIONS:

1. Apply when air is calm to avoid the possibility of drift onto desirable plants or grass.
2. Keep away from the roots of desirable plants and trees.
3. Use only in areas where complete control of all vegetation is desired.
4. Pramitol RTU should not be used on cultivated areas, on ground that is to be cultivated, in greenhouses, or near the drip line of trees or shrubs.
5. Do not use on slopes or in areas where runoff is likely to occur (apply only to level surfaces).
6. Avoid using where adjacent desirable trees, shrubs, or plants may be injured from leaching of the chemical through the soil.
7. Keep children and animals off treated areas until these areas are dry.
