#### **GENERAL INFORMATION**

Pramitol RTU will kill almost all vegetation down to the roots and prevent plant regrowth. When applied to the soil, this product can inhibit plant growth for up to one year. Use around the home, the business, or workplace where no plant growth is desired. Pramitol RTU is intended for bare ground vegetation control in driveways, sidewalks, brick walks, paths, patios, parking areas, play areas, along fences and curbs, around buildings, and under graveled pathways where plant growth has come through these surfaces. This product is intended for use without dilution.

EPA Reg. No. 66222-52 EPA Est. No. Do not use on lawns, flower beds, or vegetable gardens. Pramitol 1.8%RTU should not be applied over the root zones of desirable trees or shrubs. Do not apply in sloped areas where runoff may adversely affect desirable plants.

Although Pramitol RTU has considerable activity through foliar contact, much of its activity is through roots; therefore, its effectiveness is dependent on rainfall to move it into the root zone. Very dry soil conditions and lack of sufficient rainfall may result in poor weed control. For best results, if the soil is dry, water lightly before treatment. Apply Pramitol 1.8%RTU directly to weeds and grass. Thoroughly wet weeds but do not soak as runoff may occur. Two days following application, lightly water the treated area. This will aid in the killing and prevention of weeds through root absorption.

Do not allow entry into the treated area until sprays have dried.

#### WHEN TO APPLY

For best results, apply to bare ground or when weed growth is just starting. Weeds taller than 4 inches should be hoed or cut to 1-inch in height before treatment or it may be necessary to make a second application. A second application may also be necessary to control deep-rooted perennial weeds. In areas of heavy rainfall, repeat applications may be required every six months.

#### **HOW TO APPLY**

For control of annual and susceptible perennia weeds, use thelower rates listed in the table below. For control of hard-to-kill perennial broadleaf and grass weeds, use the higher rates listed below.

Apply ONLY with a sprinkling can unless applying this product in remote locations where possible drifting is NOT a concern; then a plastic tank sprayer may be used in lieu of the sprinkling can. When using a sprinkling can or plastic tank sprayer, triple rinse and pour rinsate on area treated once application is complete. Measure out Mix only the quantity needed for the area to be treated and use immediately.

For best results, apply Pramitol RTU so it can contact and be absorbed into target weeds and surrounding soil. To prevent growth of weeds under asphalt driveways, parking areas or tennis courts, and play areas, apply Pramitol RTU to excavated areas and saturate soil BEFORE surface areas are finished.

**IMPORTANT:** To avoid damage to desirable plants, apply when it is not windy. Windy conditions may cause inadvertent drifting to desirable plants. DO NOT apply over the root zones of desirable trees and shrubs. - 1. Apply when air is calm to avoid the possibility of drift onto desirable plants or grass.
- 2. Keep away from the roots of desirable plants and trees.
- 3. Use only in areas where complete control of all vegetation is desired.
- 4. Pramitol RTU should not be used on cultivated areas, on ground that is to be cultivated, in greenhouses, or near the drip line of trees or shrubs.
- 5. Do not use on slopes or in areas where runoff is likely to occur (apply only to level surfaces).
- 6. Avoid using where adjacent desirable trees, shrubs, or plants may be injured from leaching of the chemical through the soil.
- 7. Keep children and animals off treated areas until these areas are dry.

Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times. Place in trash or offer for recycling if available.

Nonrefillable Container (greater than five gallons): Nonrefillable container. Do not reuse or refill this container. Offer for recycling, if available. Clean container promptly after emptying. Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank. Fill the container ¼ full with water. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. Place in trash or offer for recycling if available.
