Makhteshim Agan of North America, Inc. will not be responsible for losses or damage resulting from use of this product in any manner not specifically authorized by Makhteshim Agan of North America, Inc.

Formulation and Mode of Action: Quali-Pro® Oxadiazon SC Herbicide is a suspension concentrate formulation containing 3.17 pounds oxadiazon per gallon. Oxidiazon is a member of the oxadiazole chemical family of herbicides. Members of this herbicide family inhibit protoporphyrinogen oxidase production (PPO inhibitor) in plants and control weeds by killing the young weed seedlings as they come in contact with the herbicide during germination. Seedlings of susceptible weeds emerge from treated soil and then wilt and die. A preemergent application of Quali-Pro® Oxadiazon SC Herbicide controls many annual grasses and broadleaf weeds in turf, conifer nurseries and on a variety of woody ornamental shrubs and trees.

Application Information: Always apply Quali-Pro® Oxadiazon SC Herbicide with a clean and properly calibrated sprayer that will apply the spray solution uniformly. Calibrate the sprayer prior to use, according to the manufacturer's directions and check daily to be certain that the equipment is working properly. Thorough and uniform spray coverage is essential for satisfactory weed control. The spray delivery system should provide a uniform spray pattern with a minimum of drift.

Restrictions for Use of Quali-Pro® Oxadiazon SC Herbicide on Landscape Plantings:

- 1. Do not use on any landscape plants except those listed above.
- 2. Do not apply within 60 days of transplanting.
- 3. Do not apply with adjuvants or drift control agents.

Tank-Mix Combinations for Ornamental Plantings and Noncropland Areas: Quali-Pro® Oxadiazon SC Herbicide may be used in combination with a non-selective herbicide such as glyphosate to control existing undesirable vegetation. When applied as a directed spray, the tank-mixture will provide preemergence and postemergence control of susceptible species listed on the respective labels of the two herbicides.

Prior to mixing Quali-Pro® Oxadiazon SC with glyphosate or any other product, first conduct a compatibility test to make sure they are compatible. Using a clear glass quart jar, conduct the test as described below:

- 1. Fill the jar three-quarters full with water.
- Add the appropriate amount of herbicide in the following order: (a) dry flowable, (b) wettable powder,
 (c) aqueous suspensions, (d) flowables, (e) liquids and (f) solutions and emulsifiable or liquid concentrates. Shake or gently stir jar after each addition to thoroughly mix.
- 3. After adding all ingredients, let the mixture stand for 15 minutes and then look for separation, large flakes, precipates, gels, and heavy oily film on the jar or other signs of incompatibility.
- 4. If the compatibility test shows signs of incompatibility, do not tank mix the product tested with Quali-Pro® Oxadiazon SC Herbicide.

When mixing, be sure that Quali-Pro® Oxadiazon SC Herbicide is added to the tank and agitated prior to introduction of a non-selective herbicide such as glyphosate. Please refer to the non-selective herbicide label for information on surfactant and spray volume to use. Only mix the amount of spray needed for immediate application needs as settling can occur if spray mixture is allowed to sit over an extended period of time.

Precautions for Tank Mixing Quali-Pro® Oxadiazon SC Herbicide and Glyphosate-

- 1. **Do not** use apply product in combination with a non-selective herbicide like glyphosate as an over-the-top spray in ornamentals or injury will occur.
- 2. **Do not** allow spray containing a non-selective herbicide to contact foliage, stems, green bark, or bare roots of desirable turfgrasses, trees, shrubs, or other desirable vegetation since severe damage or destruction will result.
