3. Conduct storage stability tests on the commercially packaged product for one year under ambient warehouse conditions. The test results need not be submitted to EPA unless one or more of the deficiencies cited in PR Notice 92-5 has been noted. However, these data should be available whenever EPA may request them.
4. Conduct a corrosion characteristics study on the commercially packaged product in conjunction with the one year storage stability tests.
5. Submit two copies of the revised final printed label for the record.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

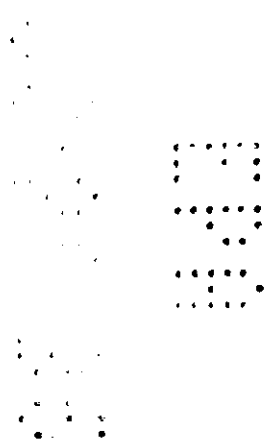
