

**POTATOES**: (Seed Pieces): Damp Off – Dust at 15 ozs. Per bushel cut seed pieces (24 oz. or  $1\frac{1}{2}$  lb. to 100 lbs. cut seed pieces). Apply in convenient container or by duster attachment over belt. Cut pieces should be treated within 6 hours of cutting. If planting is to be delayed more than 1 or 2 days the treated pieces should be stored for 2 days in open crates before bagging. Do not use treated seed for food or feed purposes.
